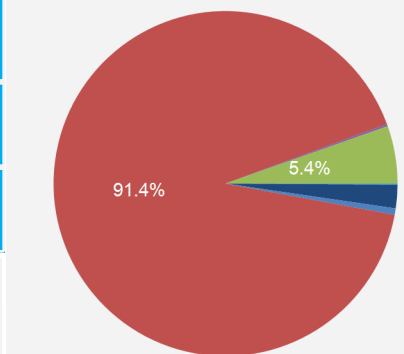

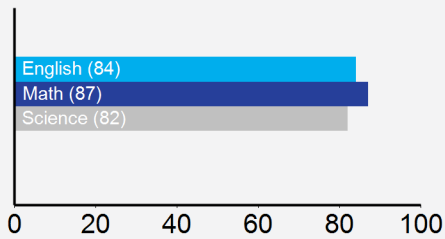

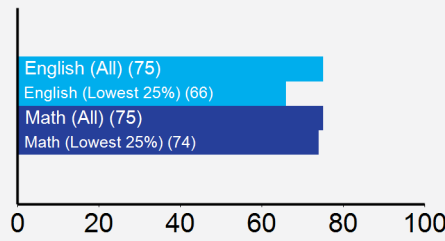


## Learning Gains

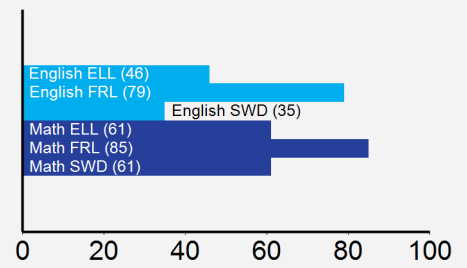

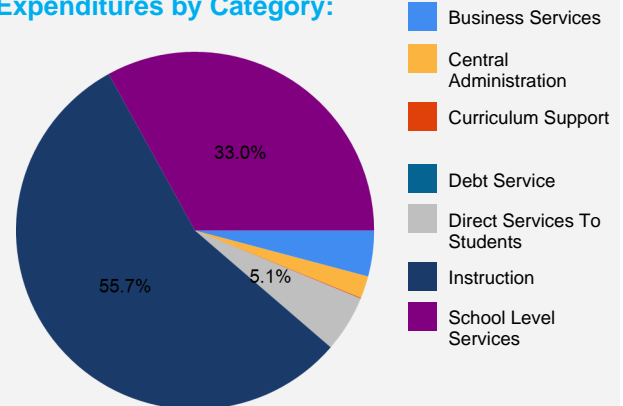
