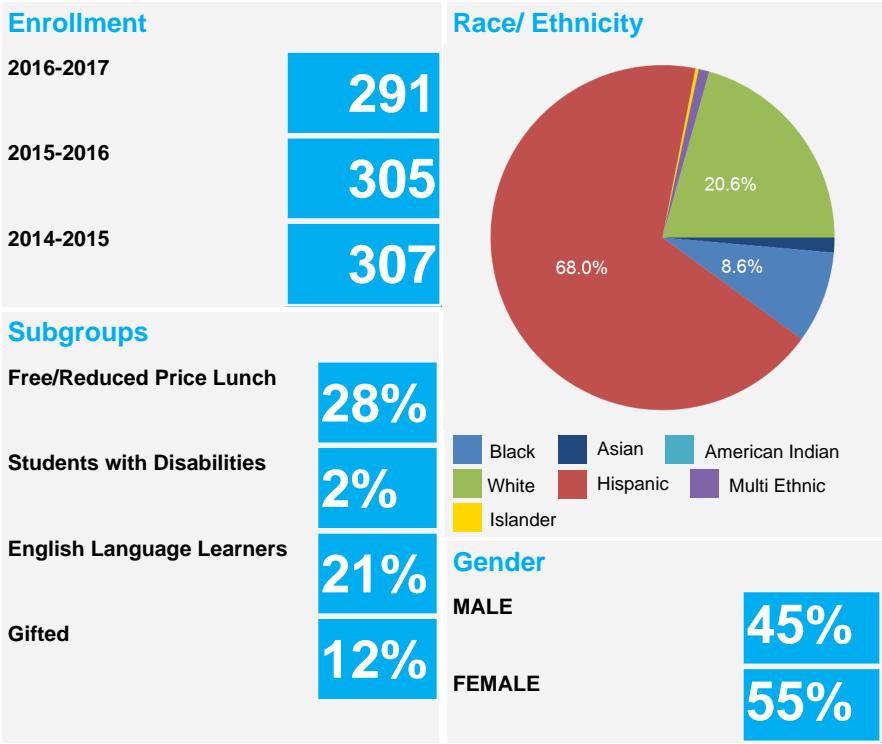

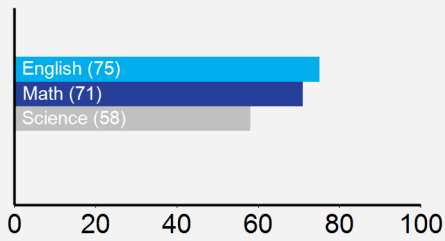

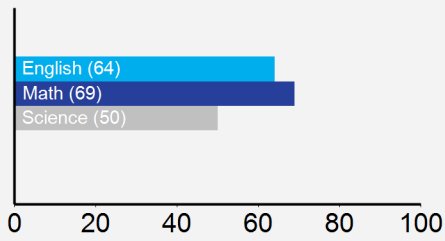
Academic Performance

Student Proficiency (%)

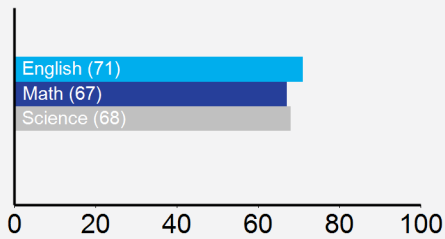

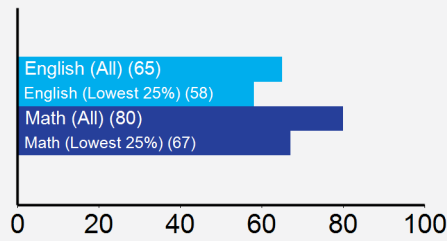

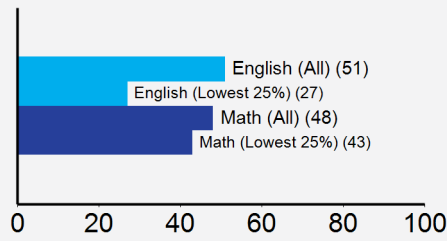


Learning Gains (%)

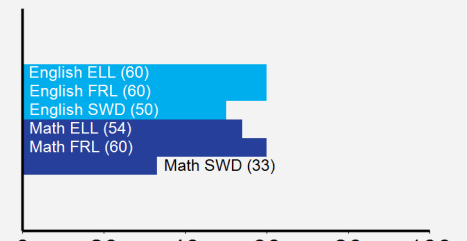

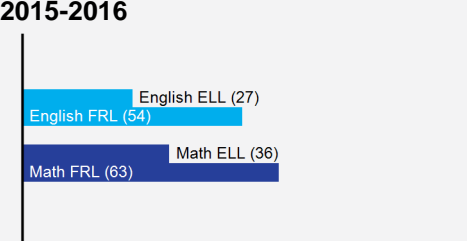

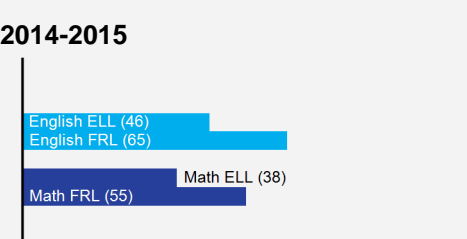

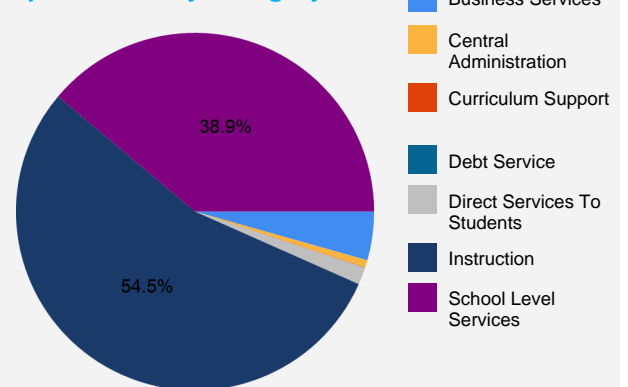
