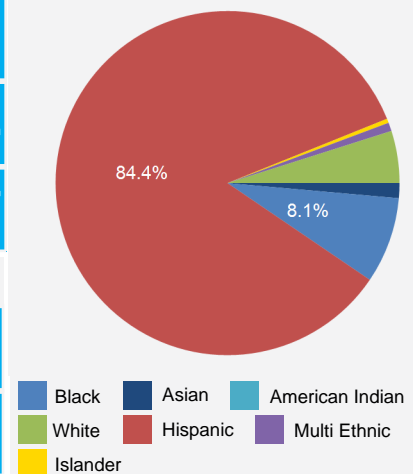

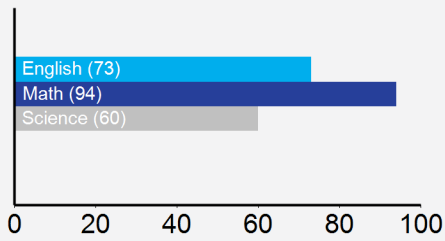

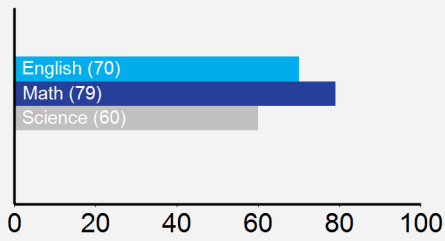

Student Proficiency (%)

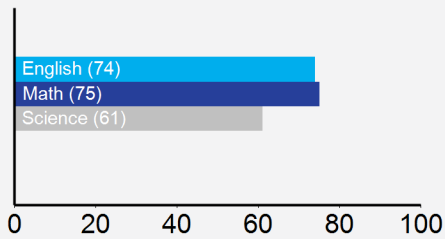

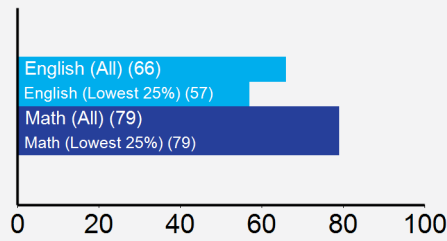

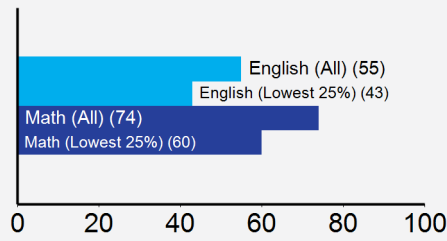


Learning Gains (%)

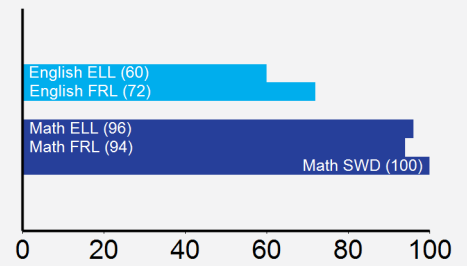

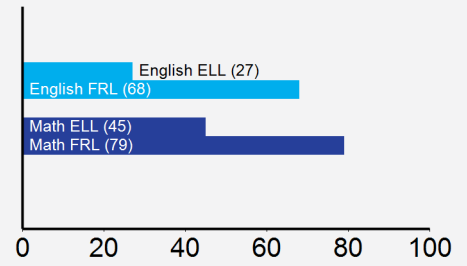

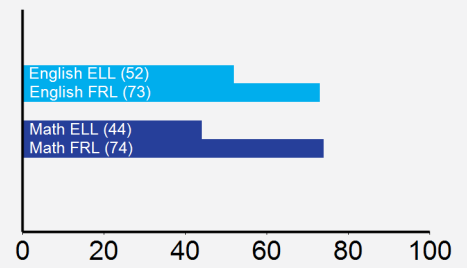

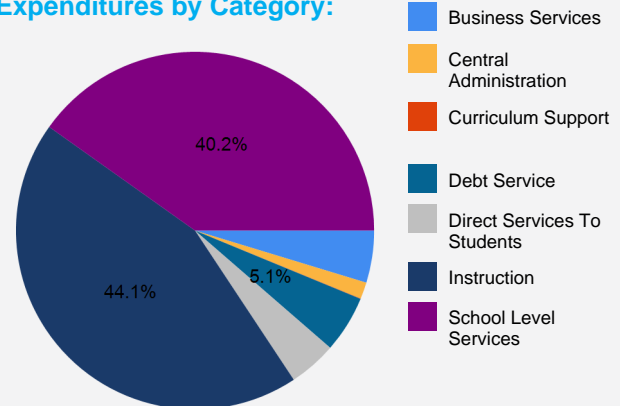
