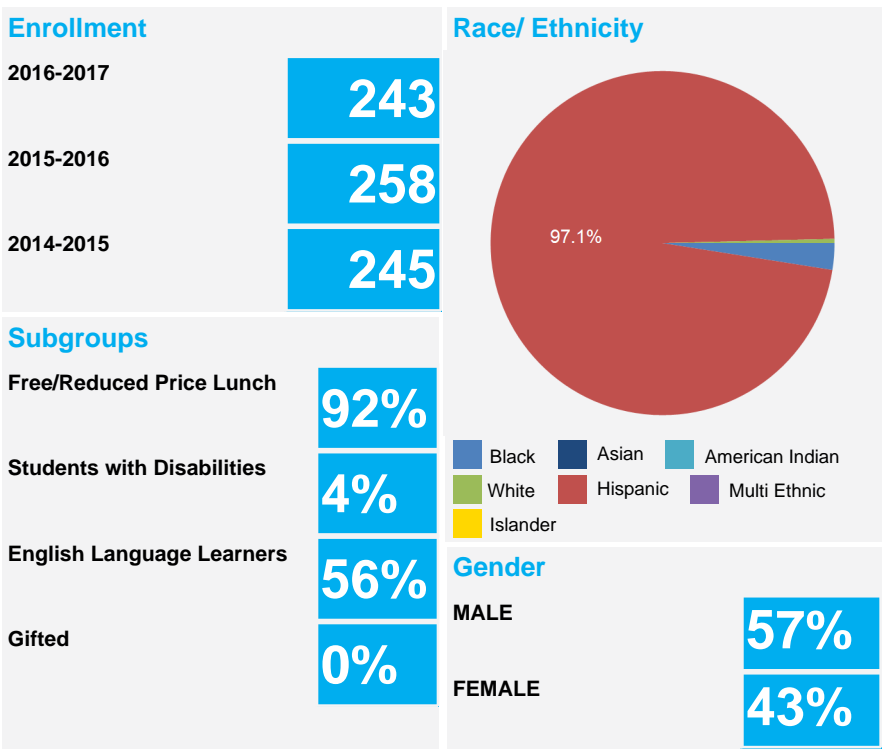

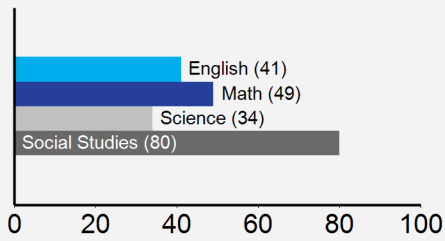

## Student Proficiency (%)

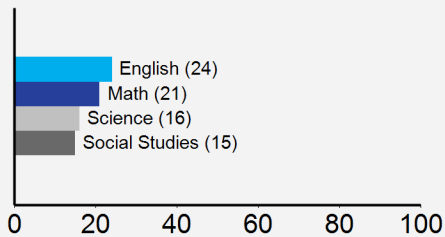

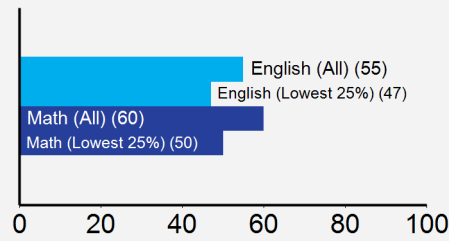

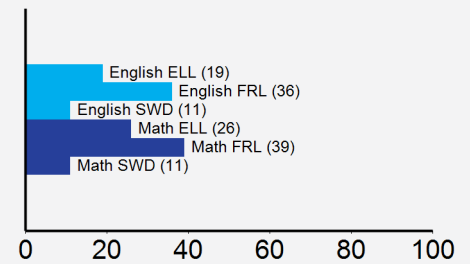

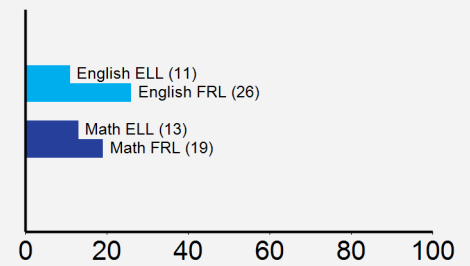

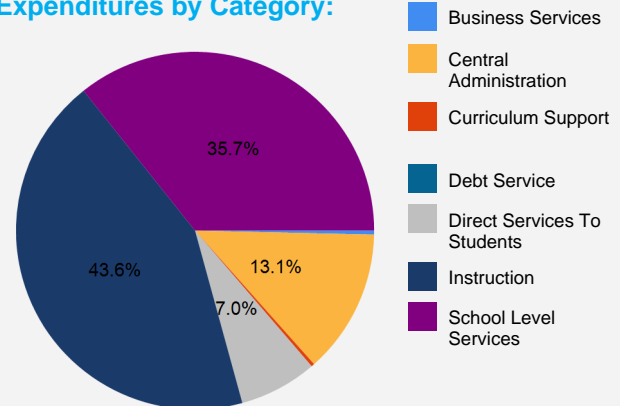
