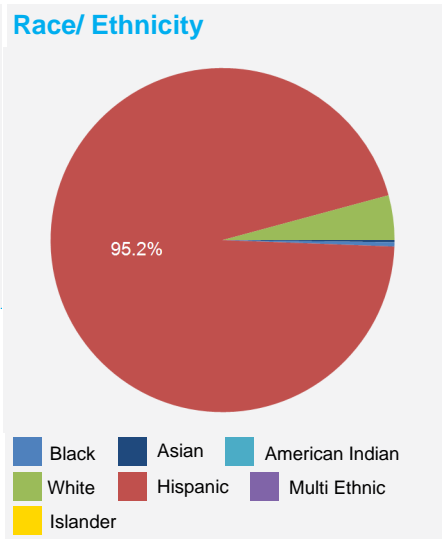

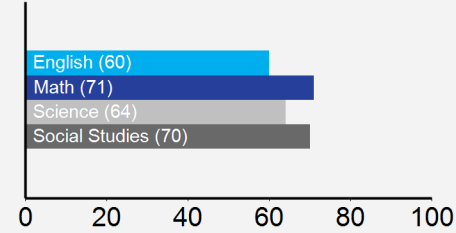

## Student Proficiency (%)

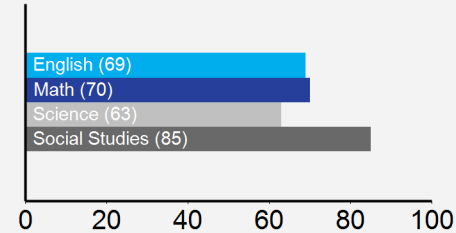

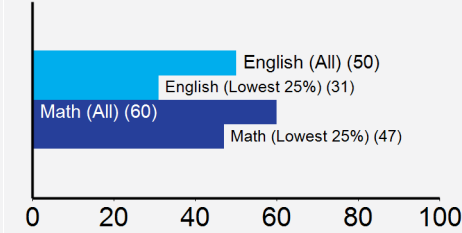

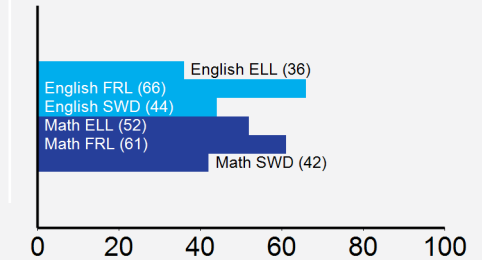

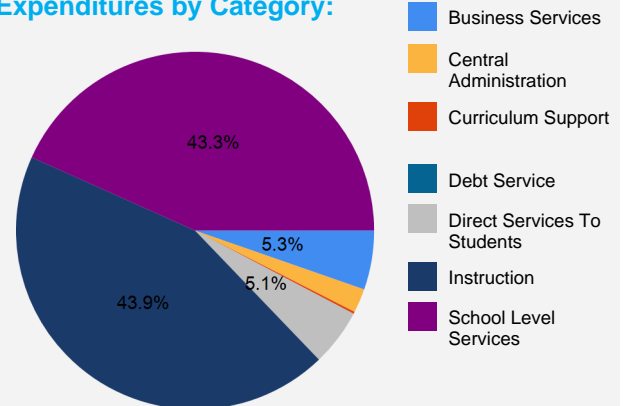
