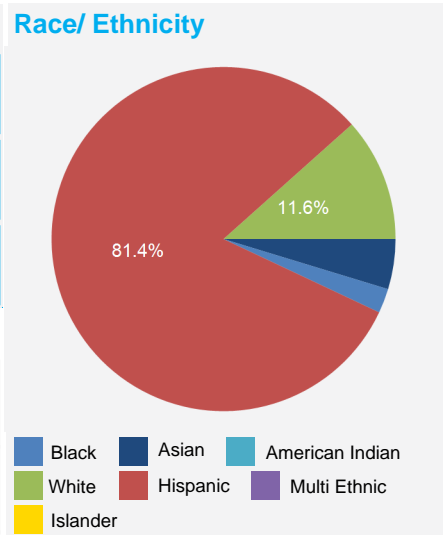

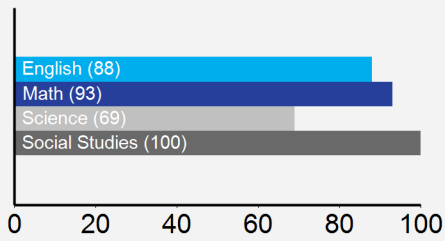

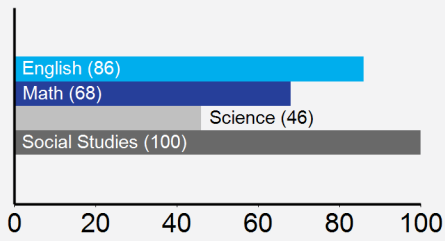

## Student Proficiency (%)

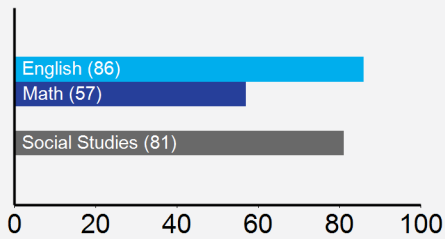

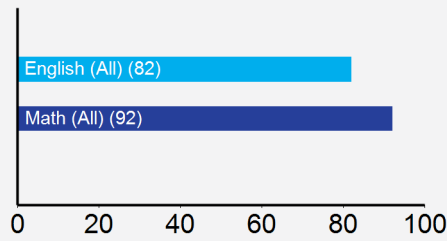

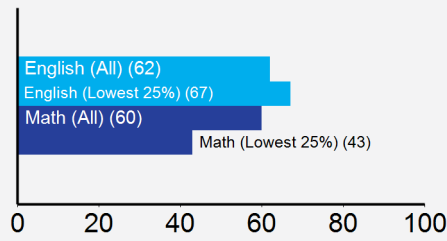


## Learning Gains (%)

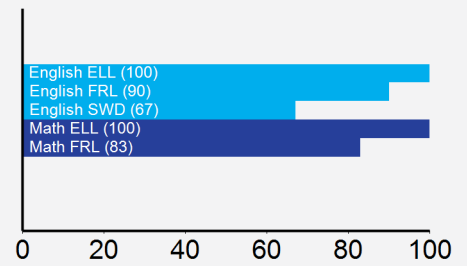

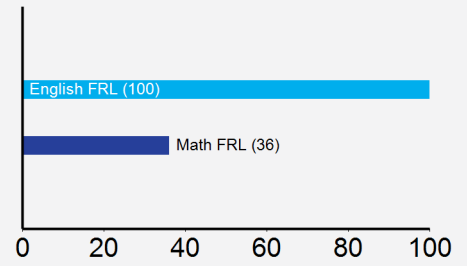

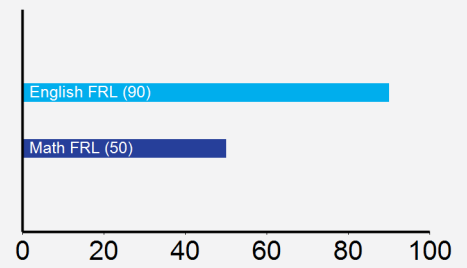

# Operational Compliance

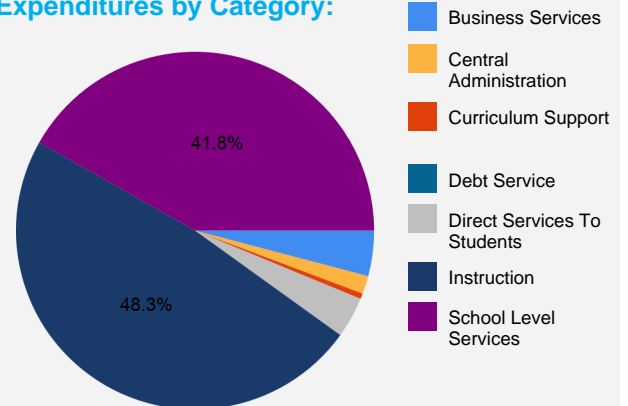
