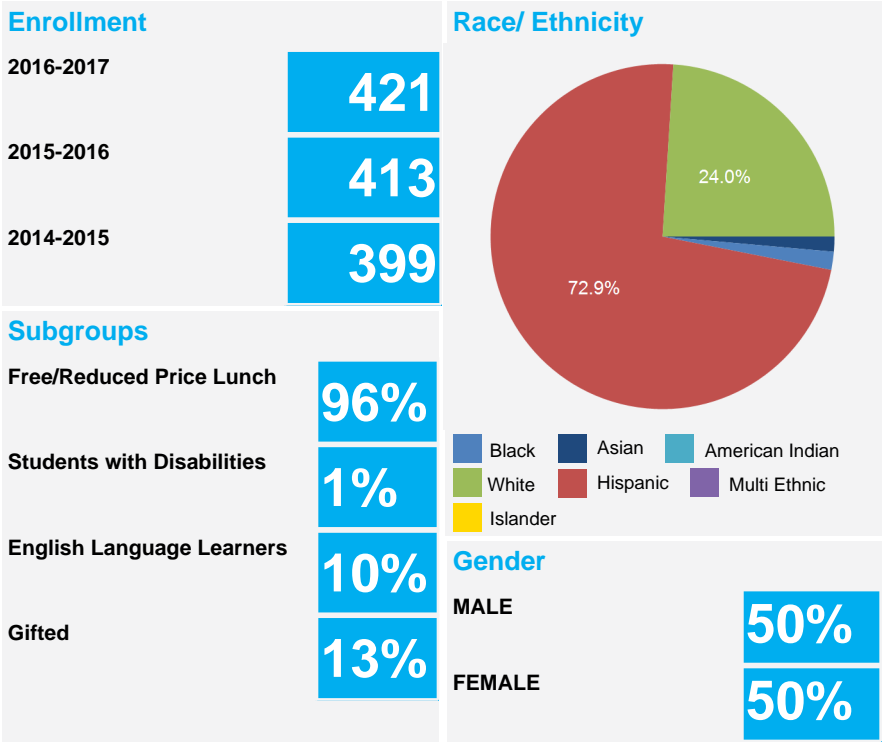

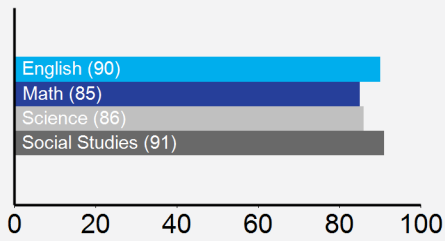

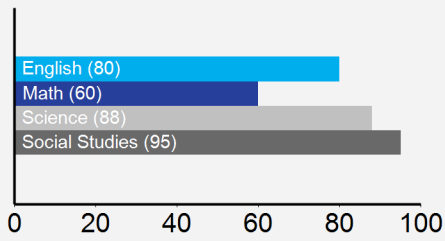

## Student Proficiency (%)

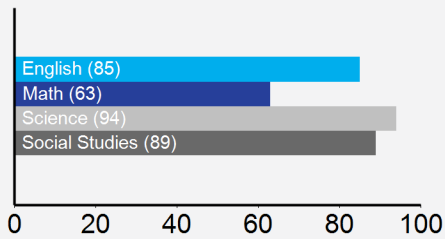

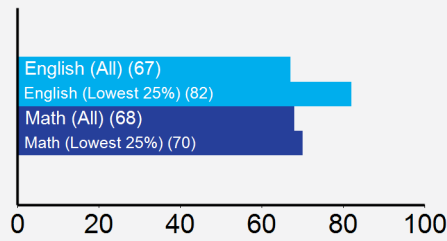

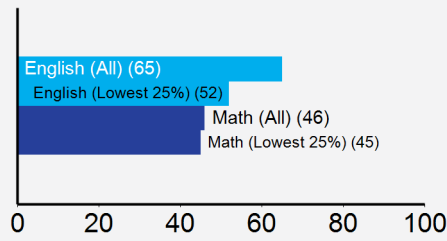


## Learning Gains (%)

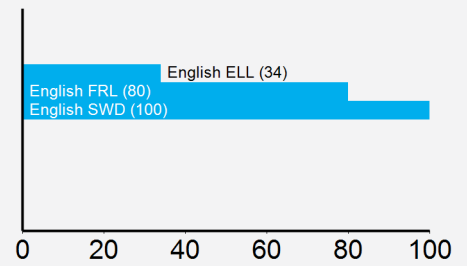

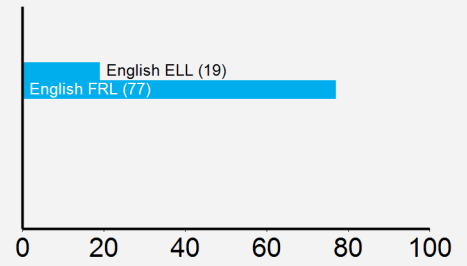

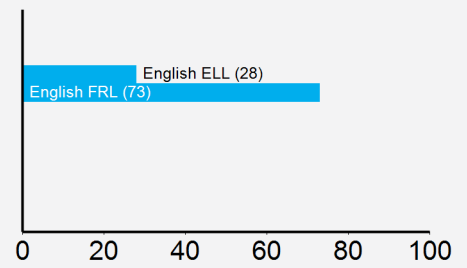

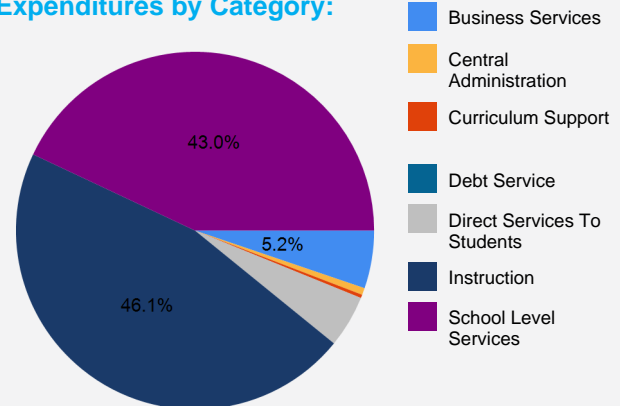
