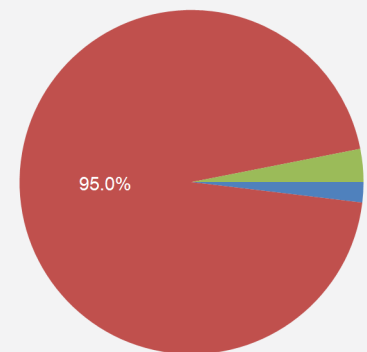

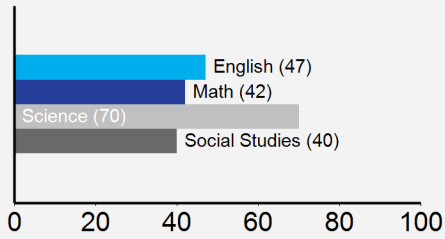

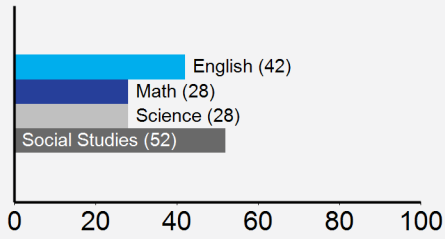

## Student Proficiency (%)

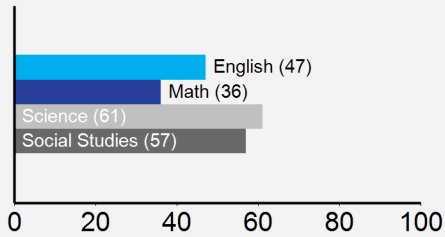

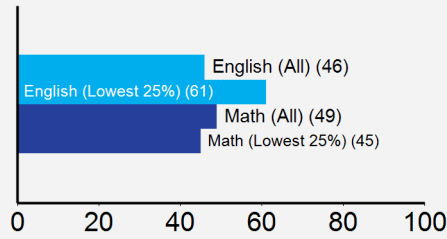

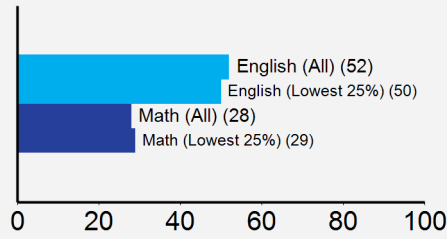

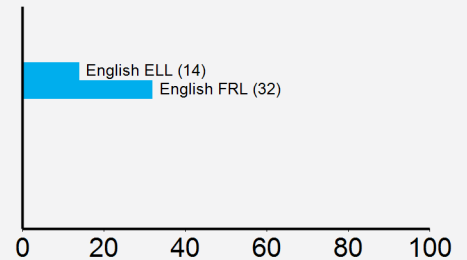

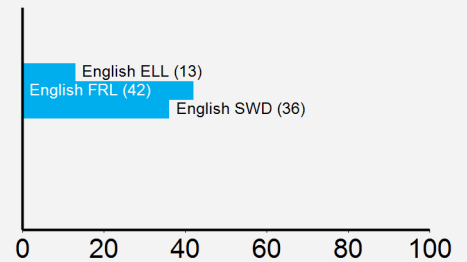

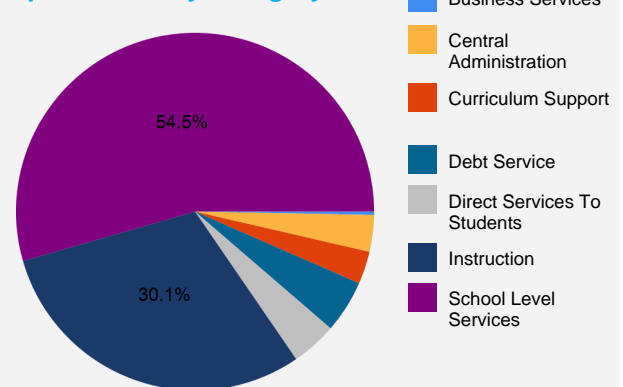
